As consideration for being permitted by GVRD to participate in these activities and use related facilities, I hereby agree that I, my assignees, heirs, distributees, guardians, and legal representatives will not make a claim against, sue, or attach the property of GVRD on account of injury or damage resulting from the negligence or other acts, however caused, by any employee, agent, or contractor of GVRD as a result of my participation in boating activity on Lake Chabot. I hereby release GVRD from all actions, claims, or demands that assignees, my heirs, distributees, guardians, legal representatives, and I now have or may hereafter have for injury or damage resulting from my participation in boating activity on Lake Chabot.

I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost, or expense, which may incur as a result of my death or any injury or property damage that I may sustain while participating in said activity. Permittee agrees to observe all applicable federal, state, and local laws and regulations.

Lake Chabot Boating Rules and Regulations

- All boats are required to have a boat permit *before* launching boat into the lake.
 - Boat Ramp Summer Hours:8:00 a.m.-6:00 p.m., April- September
Off Season Hours- 8:00 a.m.- 4:00 p.m.
 - Boating permit and valid ID required at all times
 - No gasoline engines allowed on boat, boats with inboard engines are strictly prohibited from operation on the lake per City of Vallejo Master Lease
 - No boating after sunset
 - All persons using lake for any boating activity is required to wear a Coast Guard Approved life jacket.
 - Boaters may not access shore anywhere except the boat ramp in Dan Foley Park
 - Violation of these rules will result in loss of your boating privileges
 - To report emergency accidents – Call 911

- Please note: Six Flags and GVRD share this lake and boating is only permitted on half of the lake, on the Dan Foley Park side. Boats crossing the midline of the lake towards Six Flags are considered to be trespassing.
