**INSTRUCTIONS**

1. This parcel tax exemption is for property owners who are over 65 years of age or older by June 30, 2022.
2. This parcel tax exemption is for your principal place of residence only, and applies to one parcel only.
3. You only need to apply one time for the Measure K exemption. If your application is approved, you will be eligible to receive the exemption for the entire term of the parcel tax, so long as you continue to own and occupy your principal place of residence.
4. To find your Parcel Number, look for the 10-digit number (XXXX-XXX-XXX) on your property tax bill, or call the Solano County Assessor at (707) 784-6210. You may also find your Parcel Number by entering your address into the County Assessor's Online Property Information website at [www.co.solano.ca.us/depts/ar/viewpropertyinfo.asp](http://www.co.solano.ca.us/depts/ar/viewpropertyinfo.asp).

6. **Return on or before June 30, 2022.** Applications received after this date will be submitted for the following tax year. Prior year refunds will not be granted.
7. Any parcel tax that was previously assessed on your tax bill is not refundable. Any approved exemption will apply for the remainder of the term of the parcel tax as long as the applicant continues to hold the property under identical ownership, and you continue to own and occupy it as your principal place of residence.
